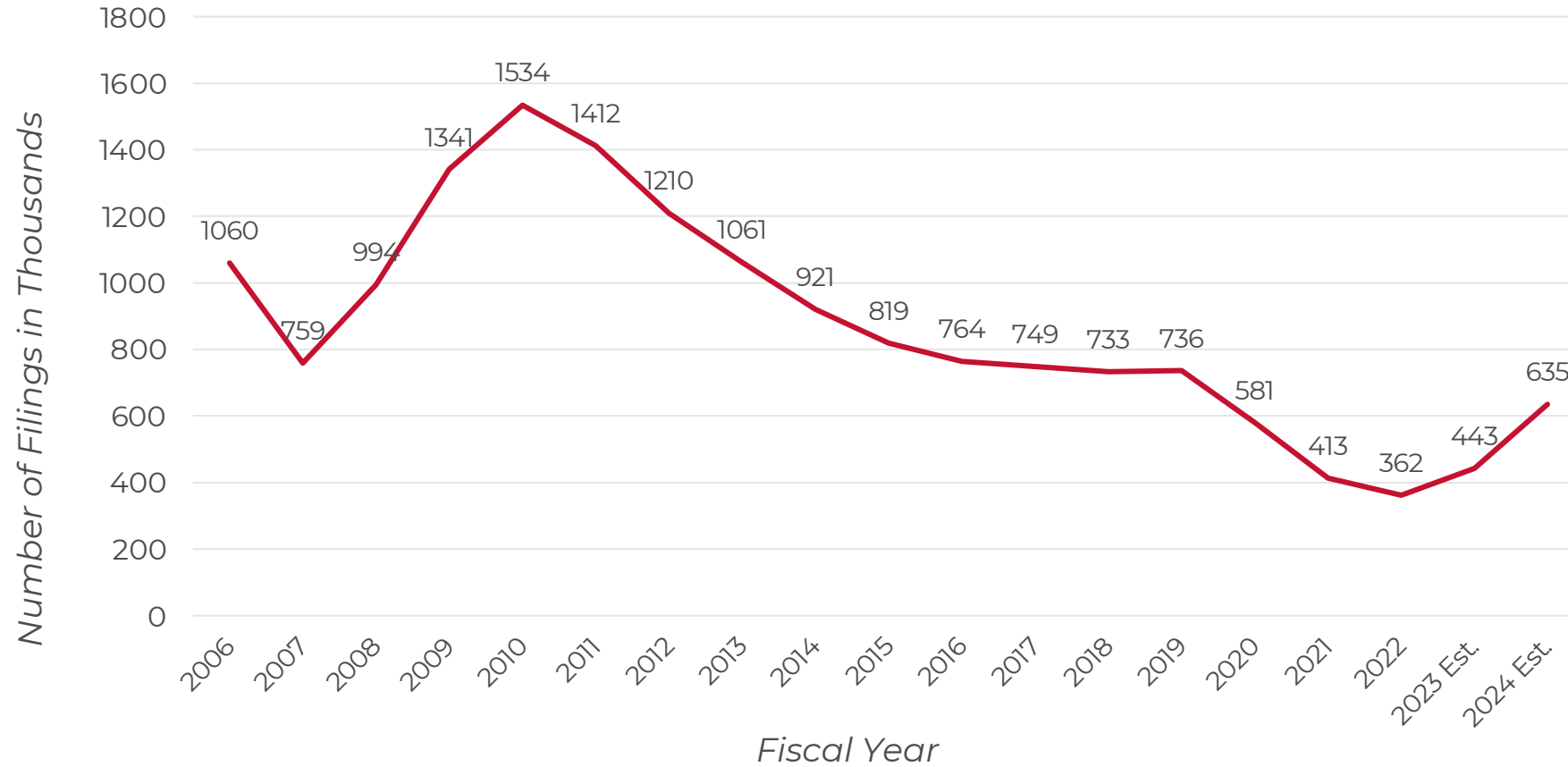

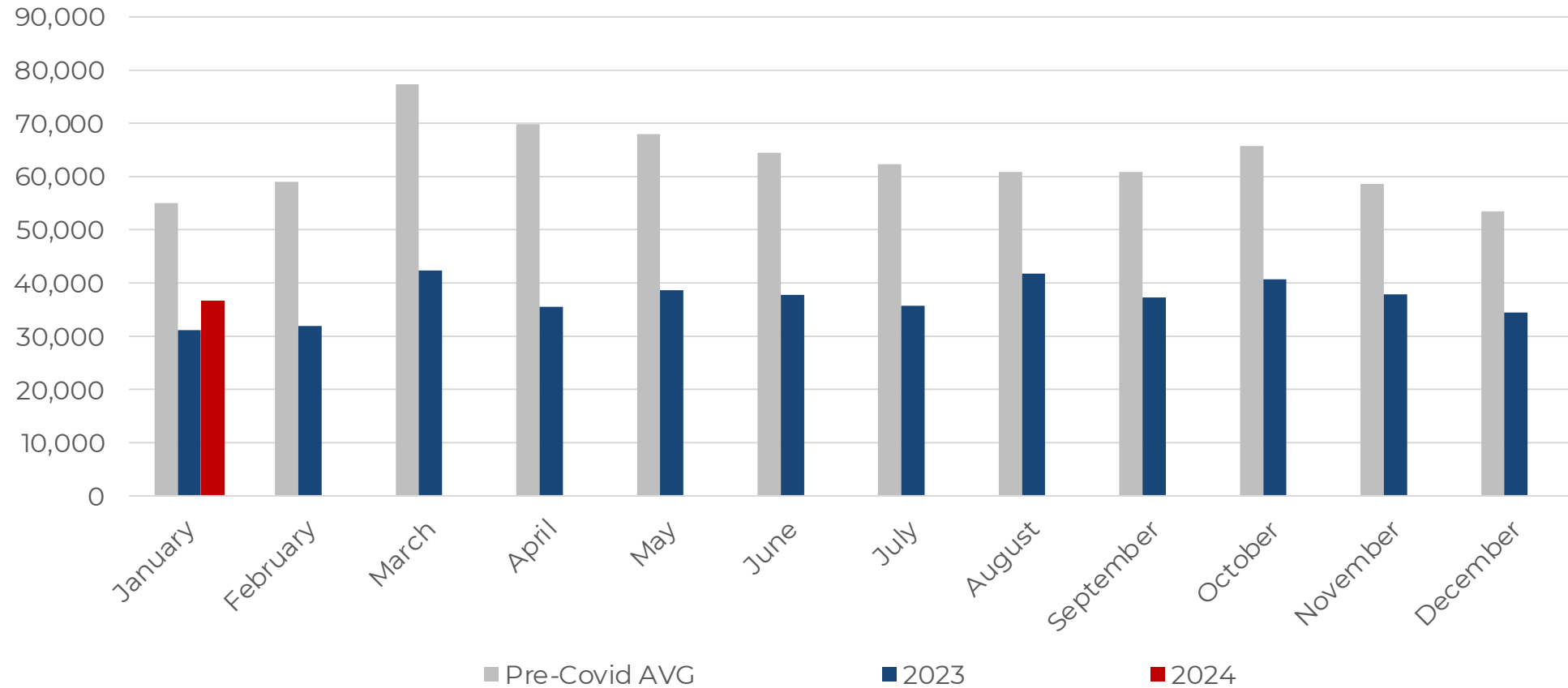
Historical and Projected Bankruptcy Case Filings in USTP Districts in Thousands

2024 MONTHLY FILING TOTALS

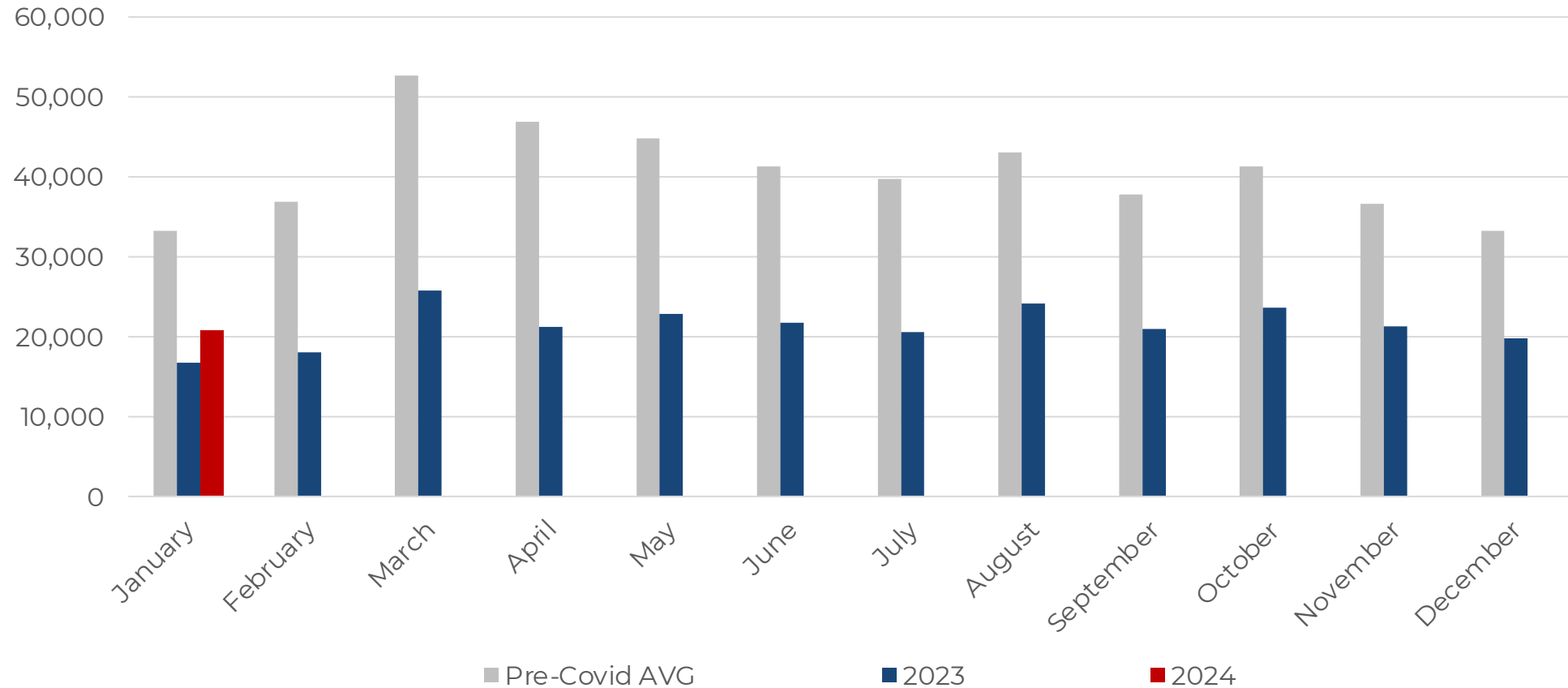
January total filings are **up 17.53%** compared to the same time period in 2023.

2023 MONTHLY CHAPTER 7 FILINGS

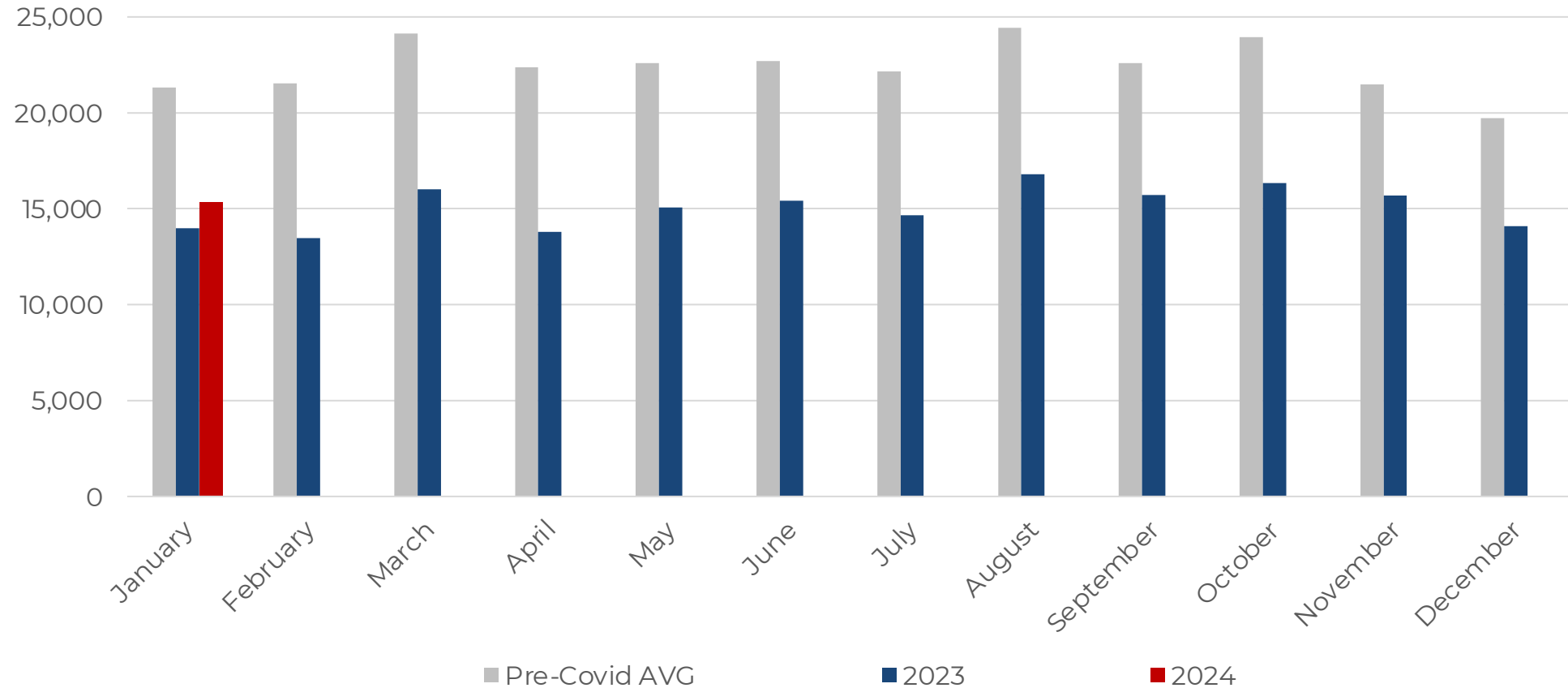
January Chapter 7s are **up 22.56%** compared to the same time period in 2023.

2023 MONTHLY CHAPTER 13 FILINGS

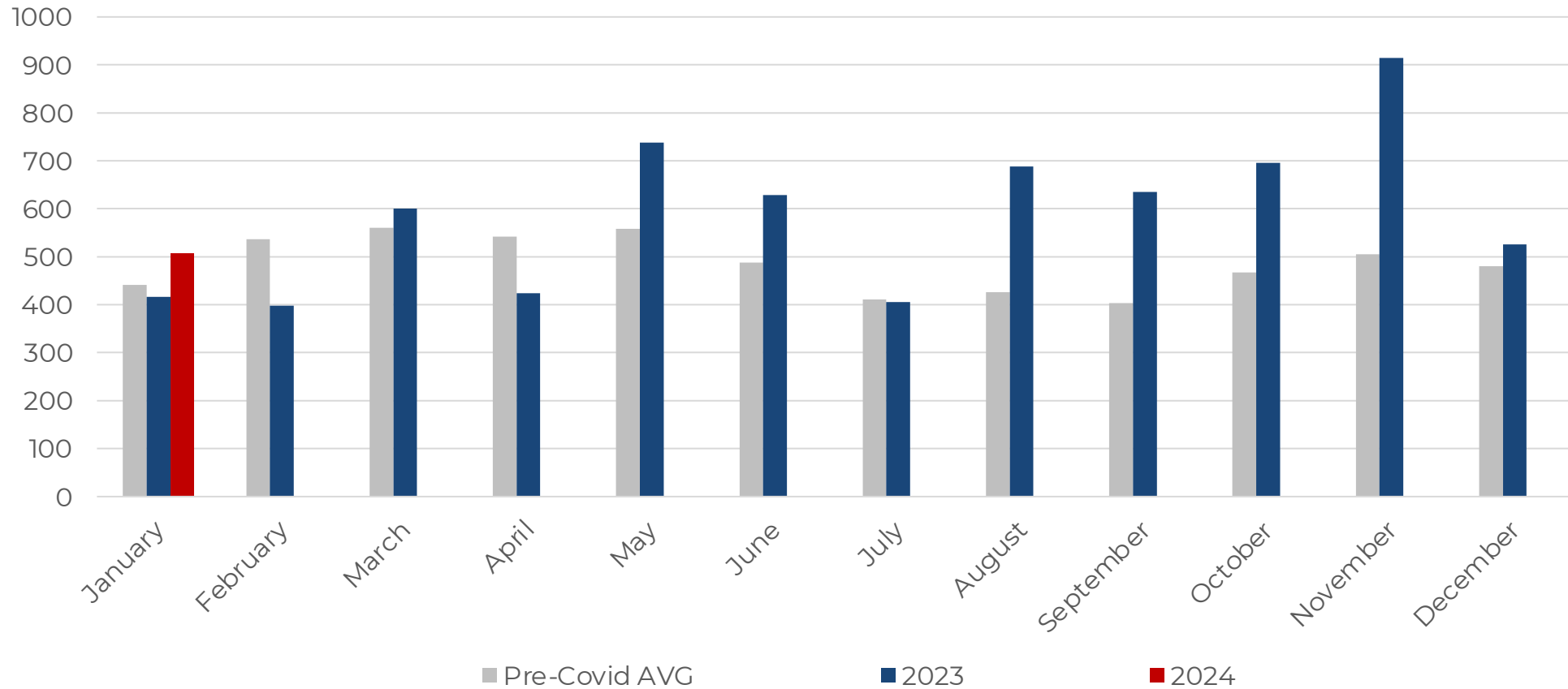
January Chapter 13s are **up 10.79%** compared to the same time period in 2023.

2023 MONTHLY CHAPTER 11 FILINGS

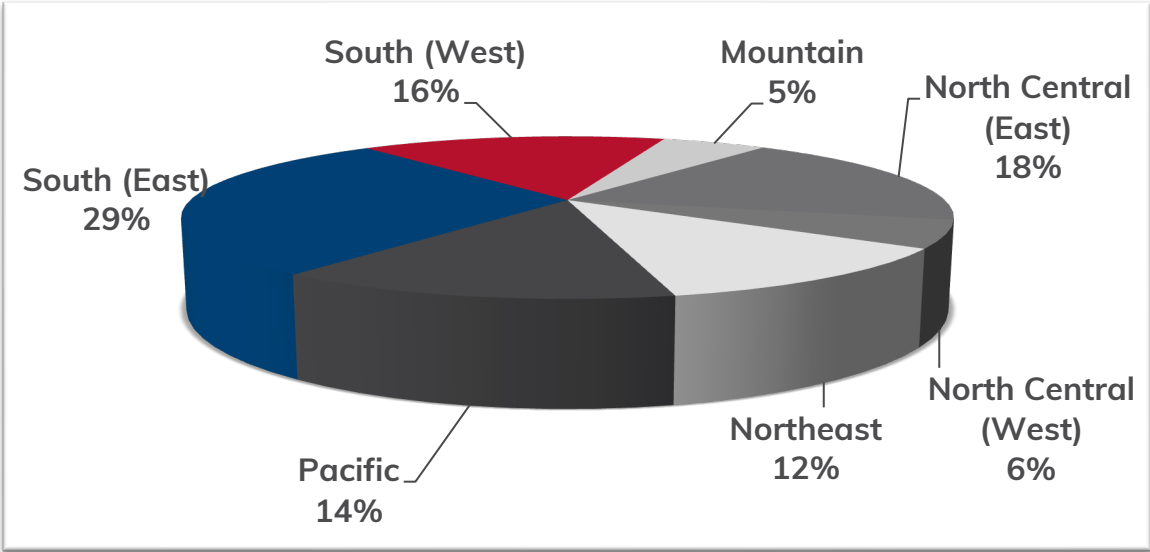
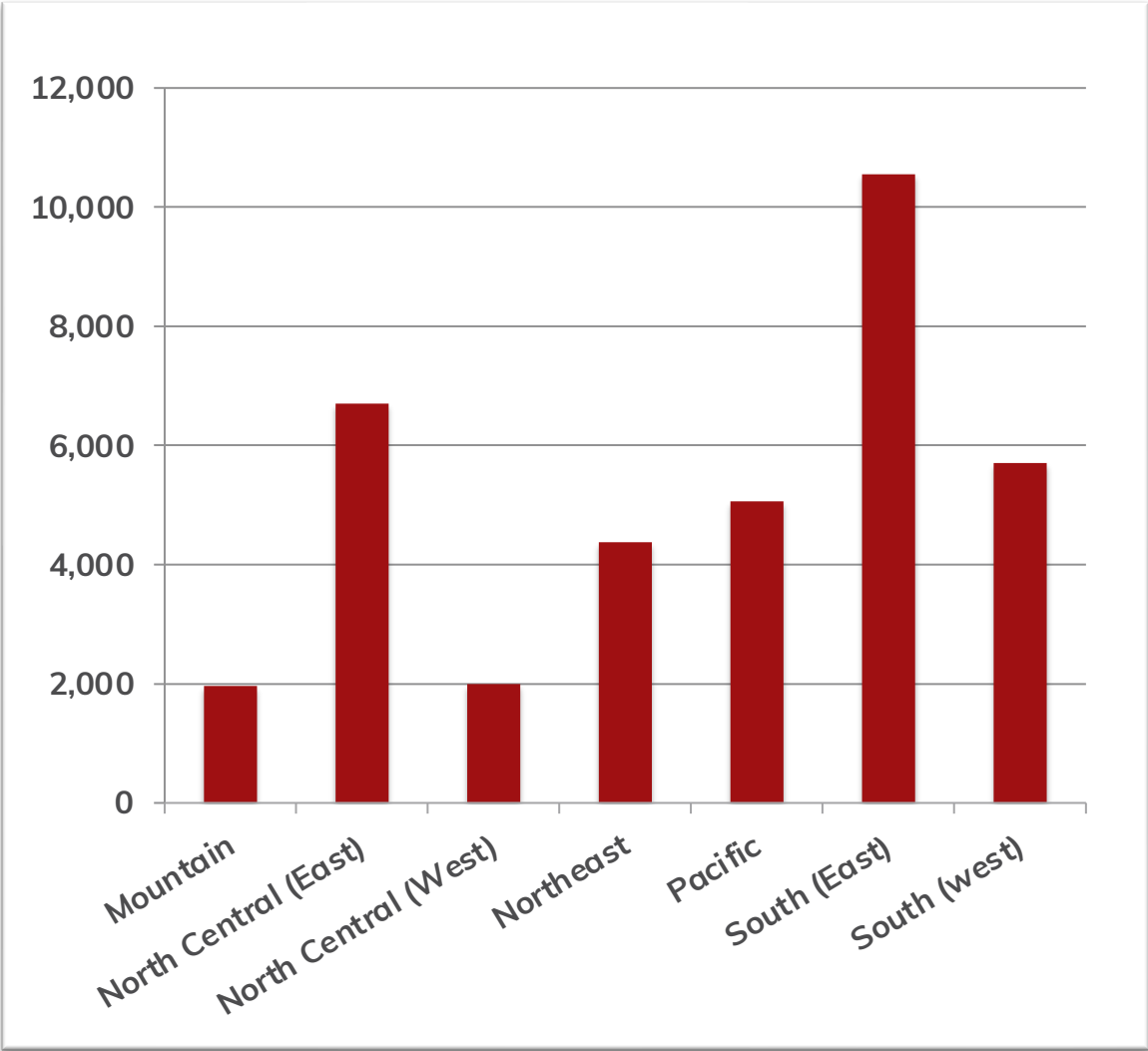
January Chapter 11s are **up 30.00%** compared to the same time period in 2023.
