








FILING PROJECTIONS



February total filings are **up 3.27**% compared to the same time period in 2024. This total is **31.66**% **below** the pre-Covid average* for the month of February.



February Chapter 7s are **up 10.90%** compared to the same time period in 2024. This total is **34.35% below** the Pre-Covid average* for the month of February.



February Chapter 13s are **up 5.23**% compared to the same time period in 2024. This total is **27.96**% **below** the pre-Covid average* for the month of February.



February Chapter 11s are **down 12.51**% compared to the same time period in 2024. This total is **3.16**% **above** the pre-Covid average* for the month of February.





