





September total filings are **up 15.45%** compared to the same time period in 2024. This total is **19.14% below** the pre-Covid average\* for the month of September.



September Chapter 7s are **up 17.69%** compared to the same time period in 2024. This total is **19.84% below** the Pre-Covid average\* for the month of September.



September Chapter 13s are **up 11.92%** compared to the same time period in 2024. This total is **20.25% below** the Pre-Covid average\* for the month of September.



September Chapter 11s are **up 13.16%** compared to the same time period in 2024. This total is **111.16% above** the Pre-Covid average\* for the month of September.





