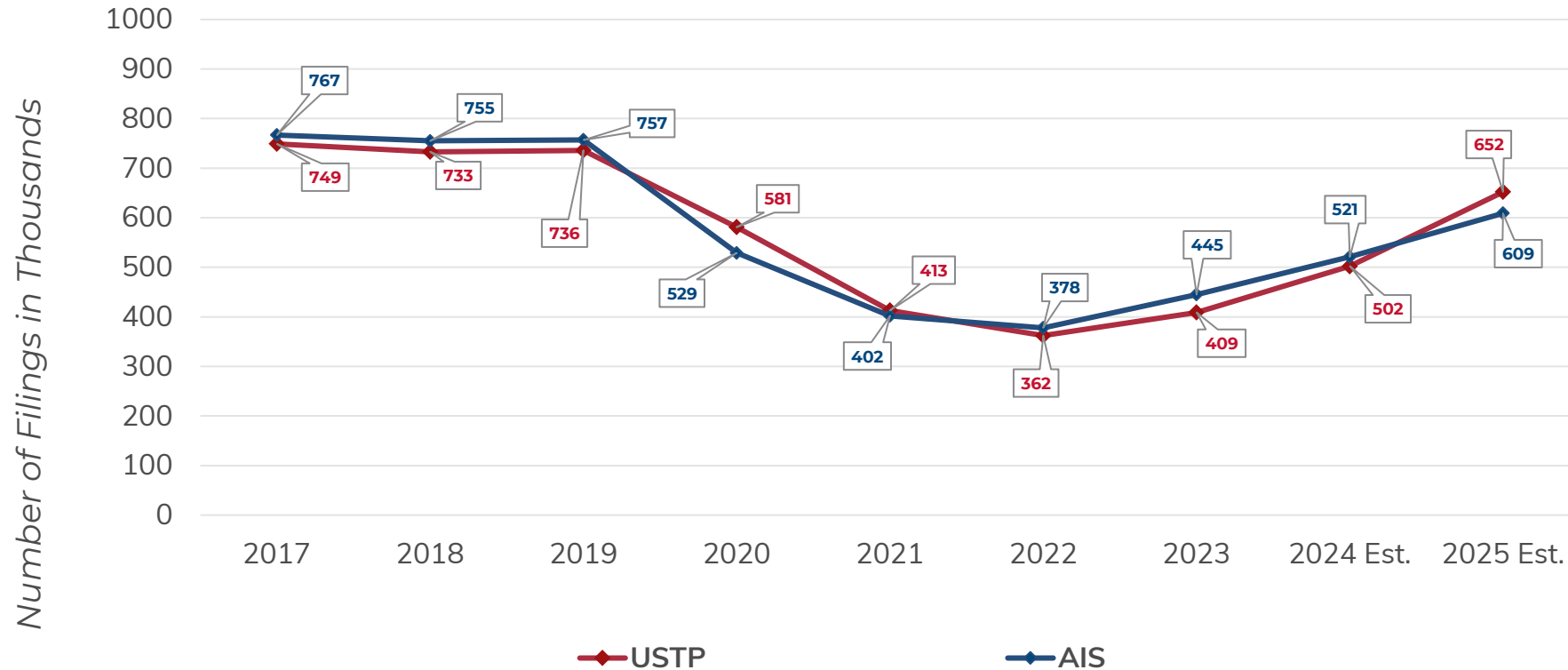

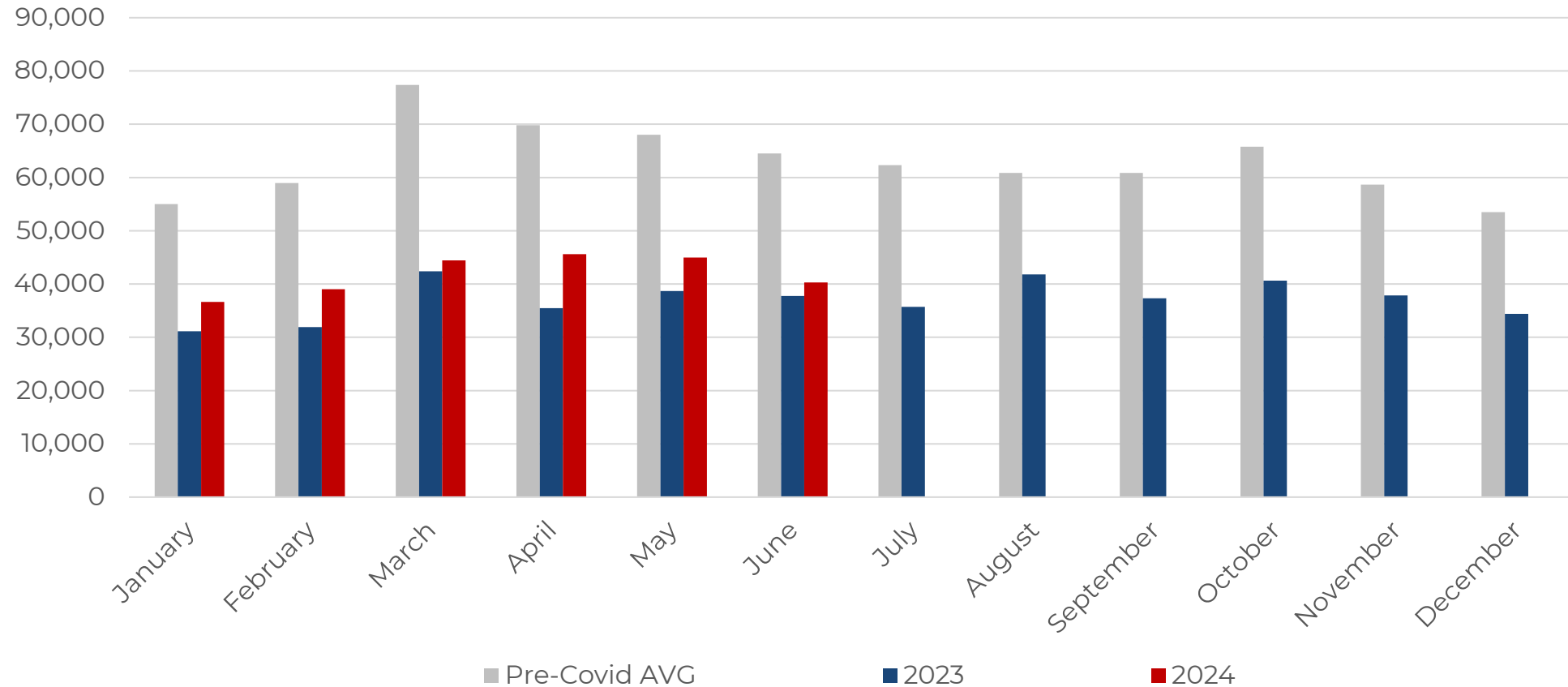

# 2024 MONTHLY FILING TOTALS

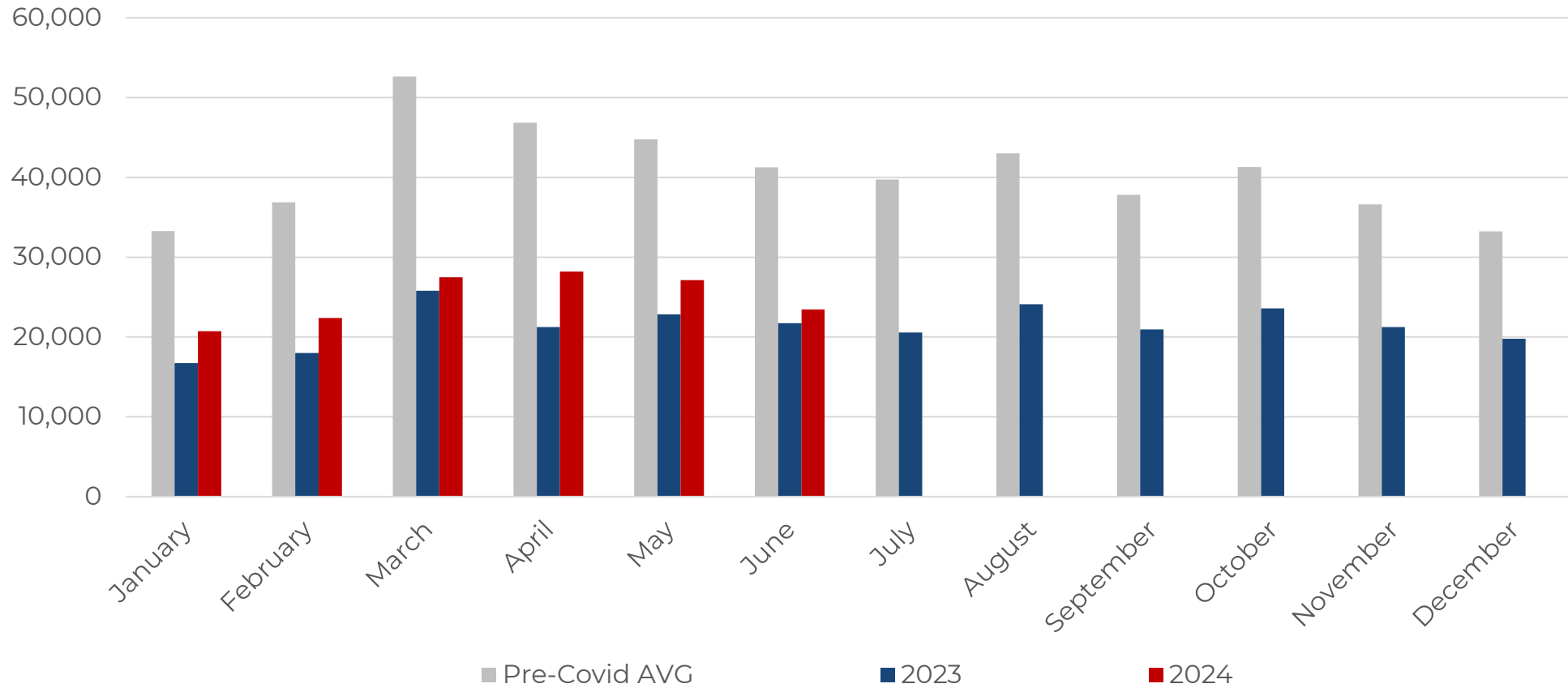
June total filings are **up 6.6%** compared to the same time period in 2023.

# 2024 MONTHLY CHAPTER 7 FILINGS

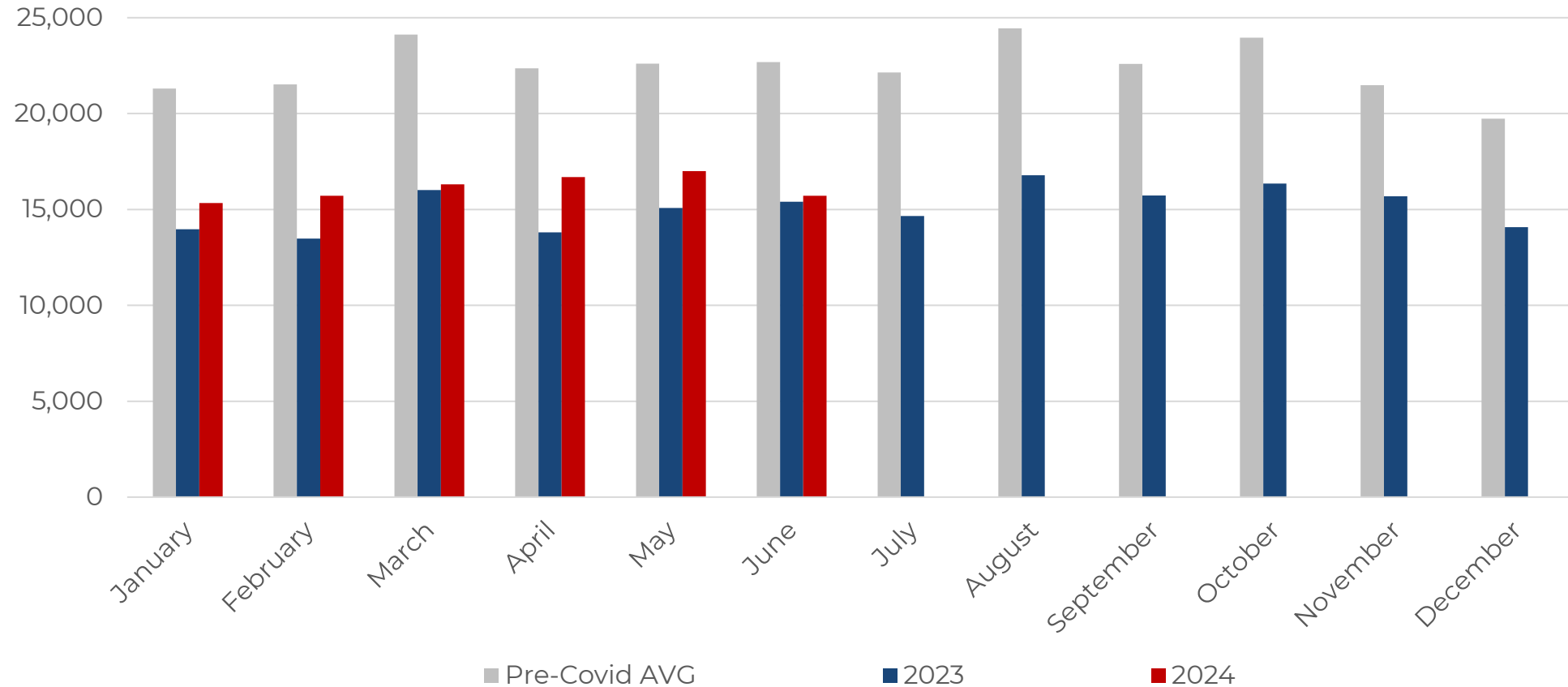
June Chapter 7s are **up 6.71%** compared to the same time period in 2023.

This total is **30.75% below** the pre-Covid average\* for the month of June.

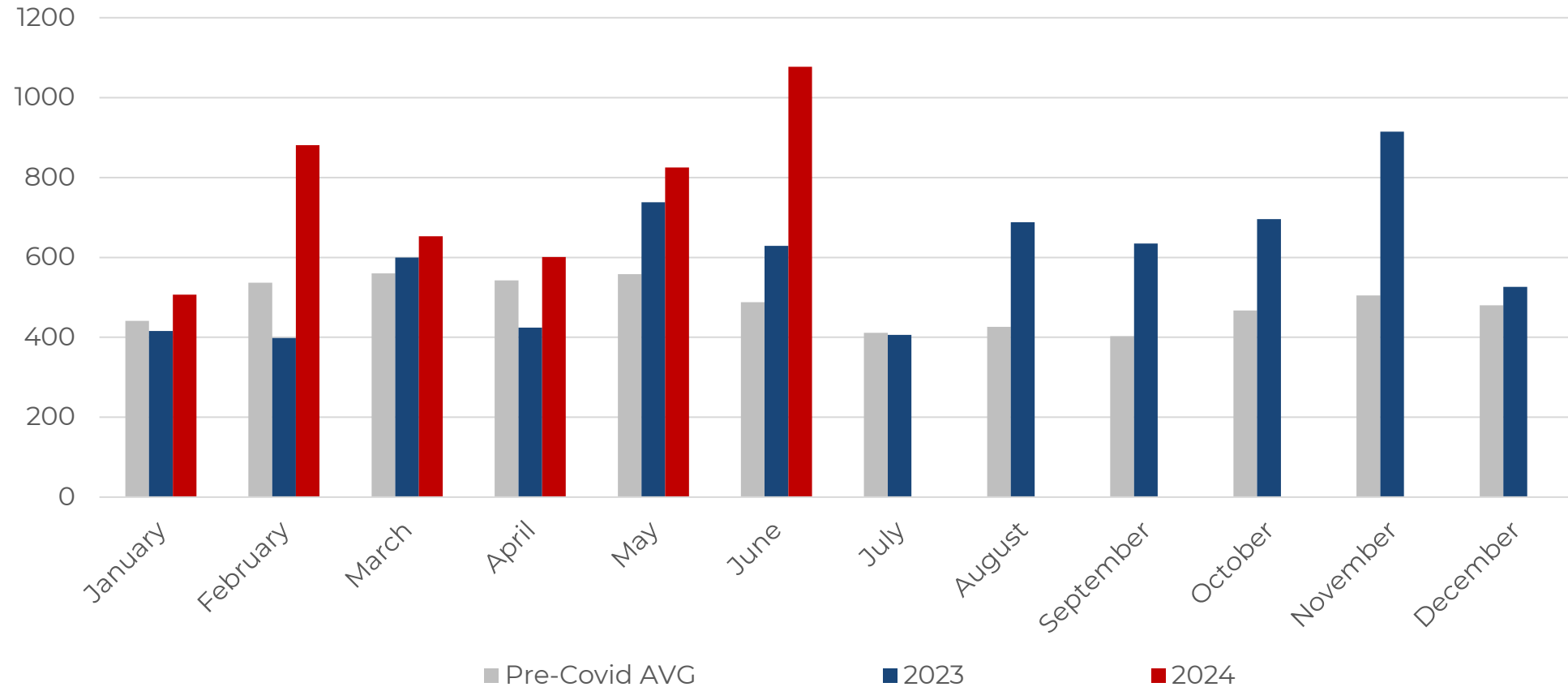

# 2024 MONTHLY CHAPTER 11 FILINGS

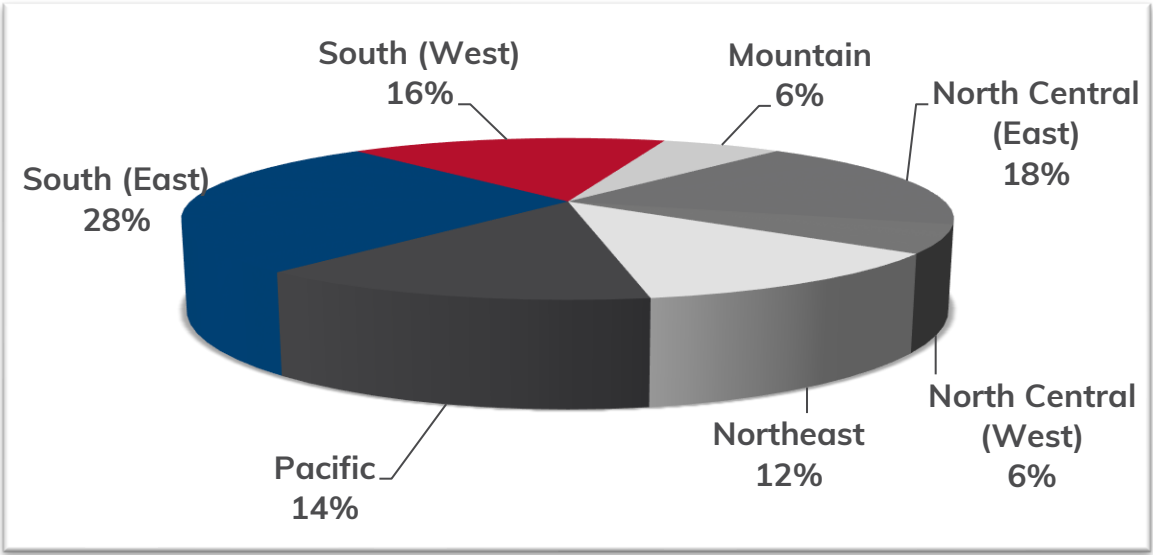
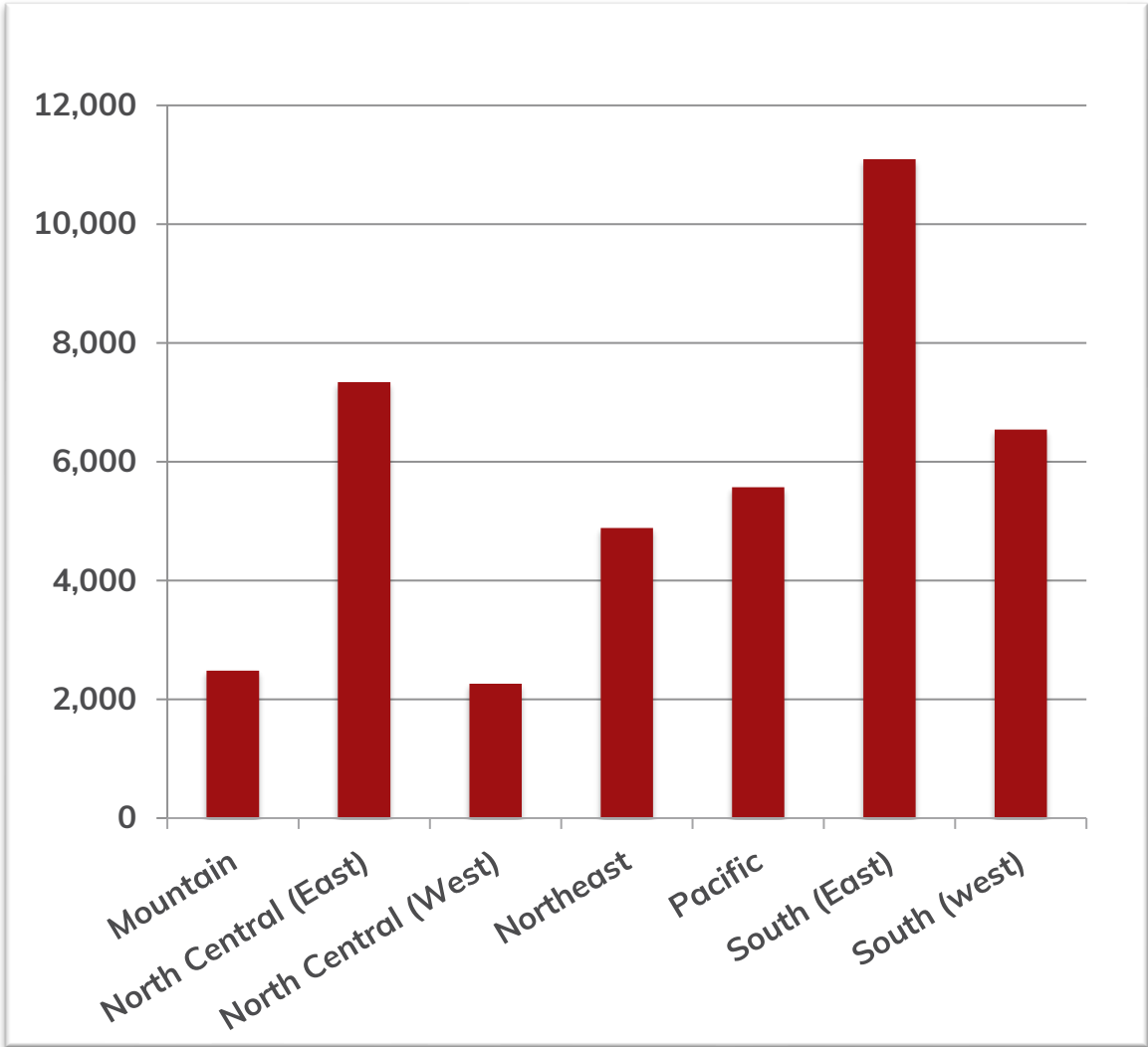
June Chapter 11s are **up 83.16%** compared to the same time period in 2023.
